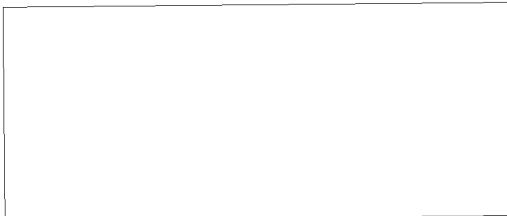
Good Afternoon Declass,
